### RENTAL FEE

All rentals carry a fee of \$10.00 plus the deposit. (See Below)

### DEPOSIT

A deposit of \$20.00 is required on all rentals in addition to the rental fee at the time of pick up.

The \$20.00 deposit will be returned to the client when they return the rental dry cleaned, with the dry cleaning tags attached and a copy of the receipt.

Any rental returned without dry cleaning tags and receipt will forfeit the \$20.00 deposit.

### RETURNS

Your rental must be returned to The Blue Boutique, no later than 7 days beyond your event date. Any rentals returned beyond this time are subject to additional fees and charges. (See Next)

### LATE FEES

Your rental period begins the day your rental is picked up. All rentals must be returned within 7 days of the event date.

The client will incur a **\$5.00 per-day late fee** on any rentals not returned within the 7 day return window. Rentals that are not returned after 14 days of the event will be considered a purchase.

The purchase price will be determined by The Blue Boutique and include any late fees incurred. The client will receive an itemized invoice and payment will be due immediately upon receipt.

### ALTERATIONS

Alterations made to better the fit of a dress are strictly prohibited on any rental. Any alterations made to the rental will result in the required purchase of the rental. If circumstances arise that cause damage during the wear of the rented dress, the client will be held responsible for any repairs, unless otherwise noted at the time of the rental.

### CANCELLATION OF RENTAL RESERVATION

Any cancellations must be made no later than 48 hours prior to your scheduled pick up date.

### RENTAL OWNERSHIP

The Blue Boutique retains ownership of all rentals until such time that the ownership is transferred through a bill of sale in which both the seller and the buyer will retain a copy for their records.
